



#### LEGAL DESCRIPTION

A PARCEL OF LAND BEING A PORTION OF THE SOUTHWEST QUARTER OF SECTION 22, TOWNSHIP 3 SOUTH, RANGE 66 WEST OF THE 6TH P.M., CITY OF AURORA, COUNTY OF ADAMS, STATE OF COLORADO MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 22 AND CONSIDERING THE WESTERLY LINE OF THE SOUTHWEST QUARTER OF SECTION 22 TO BEAR NORTH 00°00'18" WEST, WITH ALL BEARINGS CONTAINED HEREIN RELATIVE THERETO:

THENCE NORTH 32°30'47" EAST A DISTANCE OF 102.31 FEET TO A POINT ON THE EASTERLY RIGHT OF WAY OF TOWER ROAD AND THE POINT OF BEGINNING;

THENCE NORTH 00°00'18" WEST A DISTANCE OF 781.60 FEET;

THENCE NORTH 89°05'29" EAST A DISTANCE OF 2088.49 FEET;

THENCE SOUTH 00°00'18" WEST A DISTANCE OF 39.09 FEET;

THENCE SOUTH 57°06'57" EAST A DISTANCE OF 0.01 FEET TO A POINT OF CURVATURE;

THENCE ALONG A NON-TANGENT CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 31°03'12", A RADIUS OF 272.64 FEET, AN ARC LENGTH OF 147.77 FEET AND A CHORD THAT BEARS SOUTH 64°35'22" WEST A DISTANCE OF 145.96 FEET;

THENCE SOUTH 49°03'46" WEST A DISTANCE OF 48.03 FEET TO A POINT OF CURVATURE:

THENCE ALONG A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 31°05'46", A RADIUS OF 457.03 FEET, AN ARC LENGTH OF 248.04 FEET AND A CHORD THAT BEARS SOUTH 33°30'54" WEST A DISTANCE OF 245.01 FEET:

THENCE SOUTH 17°56'49" WEST A DISTANCE OF 9.57 FEET TO A POINT OF CURVATURE:

THENCE ALONG A NON-TANGENT CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 36°42'33", A RADIUS OF 335.57 FEET, AN ARC LENGTH OF 215.00 FEET AND A CHORD THAT BEARS SOUTH 00°23'13" EAST A DISTANCE OF 211.34 FEET;

THENCE SOUTH 18°44'29" EAST A DISTANCE OF 101.62 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 18°22'00", A RADIUS OF 552.65 FEET, AN ARC LENGTH OF 177.16 FEET AND A CHORD THAT BEARS SOUTH 27755'29" EAST A DISTANCE OF 176.40 FEET:

THENCE SOUTH 89°05'29" WEST A DISTANCE OF 1873.33 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 90°54'13", A RADIUS OF 25.00 FEET, AN ARC LENGTH OF 39.66 FEET AND A CHORD THAT BEARS NORTH 45°27'24" WEST A DISTANCE OF 35.63 FEET; TO THE **POINT OF BEGINNING**:
